(a) Whether the Government proposes to set up Special Economic Zone (SEZ) in the backward district Perambalur district of Tamil Nadu;

**Reply:** MOC&I may suitably reply.

There is no proposal as on date for setting up an SEZ at Perambalur district .

However, M/s. G.V.K. Perambalur SEZ Private Ltd., were issued a Formal Letter of Approval (LOA) bearing No.F.1/162/2008-SEZ dated 10.02.2009 for setting up a Multi Product SEZ at Perambalur District, Tamil Nadu. The three year validity of the LOA lapsed on 10.02.2012 in the absence of request for further extension from the Developer. The SEZ was not notified. As the validity of the Formal LOA had already lapsed, proposal for cancellation of the LOA was sent to MOC&I vide this office letter dated 03.04.2013 (copy enclosed). As per the direction of MOC&I vide e-mail dated 19.09.2013 (copy enclosed), another opportunity was given to the Developer to reconsider the SEZ proposal in the light of MOC&I amendment to SEZ Rules issued on 12<sup>th</sup> August, 2013, reducing the minimum requirement of land for an SEZ. As there was no response from the Developer, based on the recommendations of this office, MOC&I vide letter No.F.1/162/2008-SEZ dated 12<sup>th</sup> Aug, 2014 cancelled the Formal LOA issued to the Developer as per the decision of the BOA in its 62<sup>nd</sup> Meeting held on 24<sup>th</sup> July, 2014.
