Please refer to MOC&I's e-mail cited. Reply to the above Lok Sabha Unstarred Question is given below:-

- (a) Whether the Union Government has any proposal to set up a Special Economic Zone (SEZ) in Tamil Nadu?

REPLY:- MOC&I may suitably reply.

The Board of Approval has granted In Principle Approval for setting up of a Free Trade Warehousing Zone by M/s. NDR Infrastructure Pvt. Ltd. in Tamil Nadu in its meeting held on 18.06.2019.

- (b) If so, the details thereof and the time by when the proposed SEZ is likely to be set up and functional.

REPLY:- MOC&I may suitably reply.

The initial validity period of In Principle approvals is one year. The Board of Approval is empowered to grant further extensions to the In-Principle Approvals. After fulfilling the required conditions, Formal Approval is granted by BoA, the validity period of which is three years, within which time the SEZ/FTWZ is expected to be notified and made operational. The date by which the FTWZ will become operational depends on the preparedness of the private entrepreneur to get the FTWZ operational.

- (c) If not, the reasons therefor; and

- (d) The total number of SEZs being set up by the Union Government in Tamil Nadu during the last three years, year-wise.


