

NOTIFICATION-II

In excrcise of the powers conferred by section 78 of Registration Act, 1908 (Central Act XVI of 1908) the Governor of Tamil Nadu hereby makes the following amendment to the Table of fees published with the late Judicial Department Notification No.177, dated the 30th March 1909, at pages 316 to 319 of part 1 of Fort. St. George, Gazette, dated the 30th March 1909 as subsequently amended.

AMENDMENT

In the table of fee in Article 1, after clause K(C44), the following clause shall be added, namely:-

## ORDER:

With a view to boost the investors confidence in the Special Economic Zone (SEZ) Scheme (announced by the Government of India in 2000), the Government of India has been requesting this Government to implement the State Special Economic Zone policy through issue of consequential notifications / orders for Madras Export Processing Zone, Tambaram in particular which has been converted as SEZ (Special Economic Zone) Chennai (erstwhile MEPZ) with effect from 1.1.2003 and for any other Special Economic Zones in Tamil Nadu as may be approved and notified by the Government of India. Accordingly, a policy on Special Economic Zones was issued by the Government in 2003. As per the above policy, among other things, the following is included:

"All Industrial Units and their expansions to be located in the Special Economic Zones will be exempt from payment of stamp duty and registration charges towards land transaction"

In pursuance of this, Notification appended to this order will be published in the Tamil Nadu Government Gazette.

2. The Works Manager, Government Central Press, Chennai is requested to send twenty five copies of the Notification as published in the Tamil Nadu Government Gazette to Government for record.
