## 14.01 Request of M/s. Six.RN.One Global Technologies Pvt Ltd., for setting up a SEZ Unit in Span Venture Pvt Ltd SEZ, Coimbatore.

The proposal of M/s. Six.RN.One Global Technologies Pvt Ltd., for setting up their SEZ Unit in Span Venture Pvt Ltd SEZ, Coimbatore for the Manufacture of `Information Technology (IT) Consulting and support services, Information Technology (IT) design and development services' with a projected investment of ₹ 0.58 crore and projected NFEE of ₹ 23.50 crore over a period of 5 years with an employment generation of 30 persons was examined by the Unit Approval Committee.

After deliberations, the Committee approved the proposal in terms of Rule 18(2) of SEZ Rules, 2006.

### 14.02 Request of M/s. Optum Global Solutions (India) Private Limited, for setting up a SEZ Unit in Gateway Office Park Pvt. Ltd., Chennai.

The proposal of M/s. Optum Global Solutions (India) Private Limited, for setting up their SEZ Unit in Gateway Office Park Pvt. Ltd. SEZ, Chennai for the Manufacture of `Information Technology enabled services including back office operations, revenue accounting support centre and remote maintenance, (CPC − 998222/862) Information Technology enabled services including back office operations, revenue accounting support centre and remote maintenance (CPC- 9998319/843), Information Technology enabled services including insurance claim processing services, back office operations, revenue accounting support centre and remote maintenance services (CPC- 998319/865), Information Technology including software development services (CPC -998319/842)' with a projected investment of ₹ 19.11 crore and projected NFEE of ₹ 180.33 crore over a period of 5 years with an employment generation of 250 persons was examined by the Unit Approval Committee.

After deliberations, the Committee approved the proposal in terms of Rule 18(2) of SEZ Rules, 2006.

# 14.03 Request of M/s. Rockwell Automation India Pvt Ltd., for setting up a EOU in ESR Industrial Park, Oragadam Walajah High Road, Kancheepuram.

The proposal of M/s. Rockwell Automation India Pvt Ltd., for setting up a EOU in ESR Industrial Park, Kancheepuram for manufacture of 'Low Voltage Control Cabinets' with a projected investment of ₹ 104.91 crore and projected NFEE of ₹ 1928.54 crore over a period of 5 years with an employment generation of 227 persons was examined by the Unit Approval Committee.

After deliberations, the Committee approved the proposal in terms of Para 6.18(a) of FTP 2023 read with Para 6.38(a) of HBP 2023.

# 14.04 Request of M/s. Zone Master India Private Limited, an SEZ unit in J Matadee FTWZ SEZ, Sriperumbudur for cancellation of LoA.

M/s. Zone Master India Private Limited was issued LoA for setting up their Unit in JMatadee FTWZ SEZ, Sriperumbudur on 05.02.2020. The Unit commenced the production activities with effect from 18.05.2020.

A Showcause Notice was issued to M/s. Zone Master India Private Limited on 31.07.2024 for misusing the IEC of DTA buyer. The investigation by Customs indicated the role of the Unit and its CEO in the omissions and commissions leading to contravention of provisions of Customs Act, 1962 leading to the arrest of the CEO under Section 104 of Customs Act, 1962 and also leading to seizure of goods under Customs Act. Also the Unit violated for breach of its payment obligations under the Sub Lease Deed. Subsequently the Co-Developer cancelled the Lease Deed of the Unit and requested the Development Commissioner to cancel the LoA issued to the Unit. The Unit was granted Personal Hearing on 11.09.2024. After hearing the Unit's submission, the Development Commissioner adjudicated the Notice and issued Order dated 22.10.2024, recommending to place the proposal before Unit Approval Committee for LoA cancellation in terms of Section 16(1) of SEZ Act.

Previously a Showcause Notice was issued to M/s. Zone Master India Private Limited during December 2022 for clandestine removal of goods relating to Bill of Entry No. 1007972 dated 27.04.2022 warehoused in the Unit. The Development Commissioner adjudicated the Notice and issued Order dated 11.01.2023, imposing a penalty of ₹ 10.00 lakh under Section 11(2) read with Section 13 of the Foreign Trade (D & R) Act, 1992. Also the Unit management was cautioned categorically that if the mistake is repeated, the LoA will be cancelled at once with the fine and penalty. The Unit paid the penalty and continued their operations.

The intimation of placing the cancellation proposal was informed to the Unit as well as the Developer on 01.11.2024. The proposal for cancellation of LoA of the Unit was examined by the Unit Approval Committee. The Committee was explained about the facts and circumstances relating to the issuance of the Show Cause Notice and the Order as referred above and also the Omission and Commission under the SEZ Act, 2005 read with Customs Act and after deliberations approved the cancellation of LoA of the Unit in terms of 16(1) SEZ Act, 2005.

### 14.05 Request of M/s. Diggibyte Technologies Private Limited, an SEZ Unit in ELCOT SEZ, Hosur for acquiring additional space.

M/s. Diggibyte Technologies Private Limited, an SEZ Unit in ELCOT SEZ, Hosur has requested this office for approval of acquiring an additional space of 184.78 sq. meters (First floor (FF-1) in IT Tower Building at ELCOT IT/ITES SEZ Hosur) in the SEZ. The unit has stated the reason that as a part of their business expansion and growth plan, the management of the company has decided to take up the additional space within the same SEZ. The total area after acquisition would be 831.48 Sq.mtrs.

The Unit has also revised its projections consequent on the acquisition of the additional area, which is given below:

The unit has stated the reasons that the specified amount of built up area is necessary to meet their clients' requirements. The total area after acquisition would be 1858.06 Sq.mtrs.
